## AFPA Election – Zone Convenors and Workplace Delegates

Earlier in the year, the AEC conducted an election to select Workplace Zone Convenors and Workplace Delegates for the AFPA. This election has been finalised, however, due to insufficient nominations in certain Zones, a second election will be held to fill the remaining vacancies.
